## Library levy postponed; campaign kicks off January 11

On Friday, January 11, the Way Library Levy Committee held a kickoff for the 2008 Levy Campaign. The committee went ahead with its event at Schaller Memorial after a decision by the Way Library Board of Trustees earlier in the day to ask the City of Perrysburg to withdraw the levy from the March 4 ballot.

Way Library Director Nancy J. Kelley told the audience that the board decided to postpone the levy request after hearing from the Wood County Prosecutor's Office that the ballot language contained flaws.

"We certainly want the levy request to read in such a way that everyone knows exactly what we are asking the voters to approve," Mrs. Kelley explained. She told the board that the intention was for the request to describe the levy as >>cont. on page 2

## LWVPA and Way to present Topical Tuesdays program Feb. 19: **Environmentalist Sandra Bihn: 'Lake Erie: Its Condition & Challenges'**

Way Library will partner with the League of Women Voters of the Perrysburg Area (LWVPA) to present the next Topical Tuesdays program. On Tuesday, February 19, at 7 p.m., Sandra Bihn of the Great Lakes WATERKEEPER® Association will speak on "Lake Erie: Its Condition and Challenges." This program is free, and refreshments will be provided courtesy of the LWVPA membership committee.

A resident of Oregon, Ohio, Ms. Bihn has spent more than 20 years working on environmental issues affecting the Western basin of Lake Erie—dredging, power plants, water quality, and air/industrial pollutants such as phosphorous and mercury. With an MBA from the University of Toledo, she has served as a municipal chief fiscal officer and has authored state

legislation on hazardous waste fees and provided testimony on various proposals for waste disposal. She has served on the **Hazardous Waste Reduction** Task Force of the Office of Technology and Assessment and developed a municipal recycling program.

Ms. Bihn has served as Western Lake Erie Sierra conservation chair, on the Healing Our Wa-

ters Coalition, and won the Environmental Watchdog Award from the Ohio Environmental Council. She also is president of the Toledo Lighthouse Society.

<<a "four-year replacement of the existing 1.0-mill levy with an increase of 0.5 mill for current expenses."

Way Library is a municipal library, and its taxing authority is the City of Perrysburg. In the fall, the library board submitted to City Council a resolution seeking a replacement levy for the existing levy set to expire at the end of this year. Council approved the request and passed its own resolution which it then submitted to the Wood County Board of Elections. The final language did not reflect the statutorily recognized purpose for the levy and described it as an "additional" levy.

The board tabled its decision on the millage and the date of the levy request. See future issues of this newsletter for more information on this critical source of library funds. A 1.5-mill operating levy would raise about \$840,000 annually—or about 39% of the library's operating budget.

## 'Discovering the Fallen Timbers Battlefield' by Mike Pratt March 12

On Wednesday, March 12, at 7 p.m., Way Library, partnering with Historic Perrysburg, Inc., will present **Dr. G. Michael Pratt,** anthropology professor and associate vice president for academic affairs and dean of graduate studies at Heidelberg College, on "Discovering the Fallen Timbers Battlefield: the Archaeology of a National Historic Site."

Dr. Pratt's 1995 archaeological survey determined the actual location of the 1794 Fallen Timbers Battlefield and led Congress to create the Fallen Timbers Battlefield and Fort Miamis National Historic Site. For more than 200 years the site of the actual battle had remained unknown. Using multifaceted remote sensing, Dr. Pratt's team discovered the location and, during follow-up surveys in 2001, explored sites of potential casualties.

A native of Middletown, Ohio, Dr. Pratt received a bachelor of arts degree in anthropology at Miami University and his master's and doctorate in anthropology from Case Western Reserve. He directed the UT Regional Ohio Historic Preservation Office until 1981 when he began teaching at Heidelberg College.
